Roger Dubuis warrants its product against defects in materials and manufacturing for a period of two (2) years from the date of purchase or three (3) years from the date of purchase if you validly registered online on www.rogerdubuis.com for guarantee extension (the "Guarantee period").

If the product is returned during the Guarantee period, Roger Dubuis will repair or replace any defective watch or part free of charge within a reasonable time after the product is returned, subject to the right to charge for shipping costs.
